Report from Don Welch

Don Welch had received a call from Barry Gipe in regards to the curb at 7812 Deer Haven, it is completely destroyed as per the pictures, the resident is putting in new driveway, and the board voted to have his contractor do the curb as long as it was under \$5,000, Brian Schrimpf made this motion and Rick Taube seconded, it was unanimously for him to get it done and the Village would reimburse him. Don will talk to Barry regarding this.

Report from Libby Chipman/Village Clerk

Libby spoke about the Sheriff calls and the report that we were supposed to receive the next day from Kyle, and that she had emailed him a few times, with absolutely no response. Dave Bandre' will reach out to the Sheriff himself to see if we are going to receive these reports monthly.

Libby updated with the email on Falcon Lane from Brian Williams, provided the Blair Oaks School Board signs the agreements, they have the advertising set for April 11, 2025, Prebid at the Village Hall on April 23, 2025, at 10:00 a.m., Bid Opening will be on May 02, 2025 until 12:00 p.m., bids read aloud at 1:00 p.m., the bid will be awarded at the Regular Village Board meeting on May 07, 2025. They have met with Three Rivers and see no issues, the other little issues Brian said they are dealing with now.

Libby spoke about changing the website, wanted the office to have more control over the posting on it, spoke about the company that she would like to go with, which is Municipal Impact out of Arlington Texas. The initial cost would be about \$1,600.00, with the yearly cost of \$1,045.00, which is \$87.08 or \$95.00 a month if paid monthly. This would save us \$180.00 to \$188.00 a month, after initial set up cost, and we would have total posting control on the website. We do own our domain name. Bill Gratz asked that I reach out to the other communities here in the state that use this company and get emails or letters regarding how they like them. Dave Bandre' ask that I ask for a copy of the contract before we sign it. Calvin, that does our IT, is also doing something with the domain.
